

## Plant Commodities Permitted for Import into Australia from Pacific Island Countries

The below table has been created as a useful guide for PACER Plus countries to see what commodities are permitted for export from Pacific Island countries to Australia. 'SPC countries' has been used as this includes PACER Plus countries while also showing what market access the rest of the region has into Australia.

Please note: this document is intended as a guide only. It is not an exhaustive list of all permitted commodities, particularly for processed products. While care has been taken to ensure the accuracy of the information at the time of writing, import conditions are subject to change.

## PACER Plus IMPLEMENTATION UNIT
